- **AD's Report:** Jr. High volleyball ended their season taking 2nd in the district tournament. The last Jr. High football game is tonight. Jr. High girls' basketball practice started today. We will have one more football game on October 26th. The volleyball district tournament will be in Winifred October 31st November 3rd. A coop meeting will be held next week to hire coaches and pep band director.

Superintendent's Report:

Cathy Barta of Snowy Mountain Development has completed the Delivering Local Assistance Grant and submitted it, all 222 pages of it. The grant was for approximately \$480,000.00 to address the heating and airconditioning of the school. The deadline was extended to October 4^{th} . Grades 5-12 were invited, and attended an assembly in Ryegate dealing with human trafficking. Bozeman Green Build has informed me that they will be here the end of October to begin the solar project. The movement of the teaching staff has been a big success to date. The teachers are fitting right in and the students are responding to the strengths of each teacher. Count Day was October 7^{th} . We have 60 students enrolled at this time: High School - 16, Jr. High - 10, K-6 - 31, and Preschool - 3.
