# Lavina Public School Regular School Board Meeting March 8, 2022

On Tuesday, March 8, 2022, at 7:01 p.m. Chairman Ben Lehfeldt called the regular school board meeting to order. Trustees Jennelle Wallis and Dan Peters, Superintendent Nicole Hanson and Clerk Julie Sperry were in attendance. Guests present were Larry Ketcham, Susan Hayes, Kelli Schwehr, Brittany Boehm, Allen & Kim Grammens, Dan & Ivy Mallo and Bob Lehfeldt. Joining the meeting on Google Meet were Brianna Erfle, Rena Kouba, Angie Mozqueda, Robie Culver, Bill Lynch, Heidi Newsom, Renee Hethcox and Lynsey Heiken.

Pledge of Allegiance was recited.

**Negotiation with Lavina Teachers' Association:** Larry went over the proposed changes to the Master Agreement. Discussion will continue. Jennelle made a motion to approve a two-year contract with a 2.25% increase on the base for 2022-2023 and a 1.75% increase on the base for 2023-2024. Dan 2<sup>nd</sup>, all in favor, motion passed.

**Match for CBDG Grant Funding:** Moved from New Business. Robie and Bill presented the project plans and need for 25% of the grant amount in matching funds. Jennelle made a motion to contribute up to \$50,000 cash match for the 25% match of \$150,000. Dan 2<sup>nd</sup>, all in favor, motion passed.

- **4. Renew/Non-Renew Non-Tenure Contracts:** Jennelle made a motion to renew the contracts of all the non-tenured teachers Brittany Boehm, Brianna Erfle, Renee Hethcox, Ivy Mallo and Heidi Newsom. Dan 2<sup>nd</sup>, all in favor, motion passed.

Resolution of Intent to Impose an Increase in Levies

As an essential part of its budgeting process, the Lavina School Board of Trustees is authorized by law to impose levies to support its budget. The Lavina School Board of Trustees estimates the following increases/decreases in revenues and mills for the funds noted below for the next school fiscal year beginning July 1, 2022, using certified taxable valuations from the current school fiscal year as provided to the district:

- 2. Foundation repairs
- 3. Sidewalk repairs

Transportation increase: additional bus route and school bus

Tuition increase: anticipated tuition fees
